REPORT OF THE 27TH EACO ASSEMBLY OF BROADCASTING OPERATORS HELD ONLINE ON 8TH JULY 2021

1.0. OPENING OF THE MEETING

The 27th Assembly of Broadcasting Operators of EACO was held on online 8th July 2021.

Mr. Andrew Kisaka welcomed the participants present to the 27th Assembly of Broadcasters of EACO.

The meeting was attended by 90 members who included Broadcasting Operators and National Regulatory bodies of the EACO members, namely Burundi, Kenya, Rwanda, South Sudan, Tanzania, and Uganda the EACO Secretariat

2.0. ELECTION OF THE BUREAU

In accordance with the Rules of Procedures of the EACO, the Assembly of Broadcasting Operators elected the Rapporteurs of the bureau as follows:

3.0. ADOPTION OF THE AGENDA

6.0. HANDOVER OF THE CHAIRPERSON

The outgoing chairman of the Broadcasting Assembly Mr. Josiah Murunga from TVE Tanzania was represented by Eng. Andrew Kisaka from Tanzania, who handed over the chairmanship to Mr. Arthur Asiimwe from Rwanda Broadcasting Agency (RBA) who was represented by Mr. Innocent Nkurunziza.

Mr. Innocent Nkurunziza, thanked Tanzania for the great chairmanship for the past two years and committed to continue the good work.

7.0. PRESENTATION OF THE REPORTS OF THE WGS

Mr Andrew Kisaka the chairman of WG05 on Broadcasting Development, Spectrum Management & Media Services Regulations gave a presentation on the works of WG5.

8.0. IDENTIFY CROSS CUTTING ISSUES TO BE SHARED IN THE JOINT WORKING COMMITTEE

The Broadcast Assembly meeting identified the following cross cutting issues::

- 1) Cross border Frequency coordination requires participation of both broadcasting and mobile operators
- 2) Participation in the work of WRC-23
- 3) Market survey of digital radio receiver availability and benchmark with other countries
- 4) Promote the development and deployment of DSB as a EAC region to promote conductive regulatory environment
- 5) Develop Regulation of Internet based/ online media platforms regulation for the East African Region to maintain broadcasting ethics
- 6) Promote infrastructure Sharing in the Broadcasting Industry
- 7) Determine Lesson learnt in the promotion of CAM (one decoder): Experience from Number portability
- 8) EAC countries to develop a regional Space Agency at EAC level
- Concept paper for Cubesat Project was developed and is brought to the attention of the JWC
- 10) Involvement of Broadcasters by defining their role for active participation and discussing topical issues e.g. acquiring games right at affordable rates, artists' rights
- 11) Secretariat to facilitate presentation of accomplished regulatory frameworks from EACO to the EAC to promote awareness to policy makers within EAC.

9.0. WAY FORWARD FOR THE TORS IN REGARD TO BROADCASTING AND PLAN FOR THE BROADCASTING ASSEMBLY FOR THE NEXT CYCLE

The following were identified as way forward for the Broadcasting Assembly for the next year 2021/2022:

- 1. Follow, understand and build capacity in the latest Broadcasting technologies
- 2. Continue the work on Sustainability of FTA and come up with harmonised approach
- 3. Encourage attendance of broadcasters in the work of EACO
- 4. Promote Digital Sound Broadcasting (DSB) development and determine the right standards and licensing approach
- 5. Follow and actively participate in WRC-23 agenda items related to broadcasting services especially spectrum in the UHF band of 470-694 MHz
- 6. Broadcasting Satellite project for East Africa should be spearheaded to ensure that the objectives are realised.
- 7. EACO Member states should follow through and work together to ensure that submissions made under resolution 559 (WRC-19) are completed in time for WRC-23 consideration and approval.
- 8. Develop capacity on space technology

10.0. CLOSING OF THE BROADCASTING ASSEMBLY

In the closing remarks, the Chairman thanked the members and other participants for their participation in the Assembly meeting and were encouraged to actively participate in the future work of the Broadcasting Assembly.

In his remarks, the Executive Secretary of EACO thanked the outgoing of chairperson for work performed during in his chairmanship and thanked the incoming chairperson for leading the assembly.
